- according to the Convention on the Contract for the International Carriage of Goods by Road (CMR);
- according to national statutory regulations of the individual countries of Europe, the mediterranean-neighbouring countries and Cyprus governing national or international transport of goods by road vehicles;
- according to the customary general terms and conditions for the carriage of goods by road;

For each insured claim the insurers indemnity for freight losses and freight consequential losses shall be limited to EUR 2.500.000.

The insurer/insurers does/do not assume any obligation to third parties on the basis of this certificate. In particular, this certificate shall not oblige the insurer/insurers or OSKAR SCHUNCK GmbH & Co. KG to supply information on modifications to or the termination of this insurance cover.
